

AGREEMENT
FOR AVAILING DEFERMENT OF TUITION FEE

SUBSEQUENT PAYMENT OF IT TO NUST

2. NO Degree, migration or any other relevant document/certificate will be issued to the student unless he clears the NUST dues amounting to Rs _____.
3. The student shall undertake to pay all the dues of the NUST immediately and not later than _____ years after completion of his/her course of study unless the time is extended by Rector NUST.
4. The student will submit personal guarantee as well as by his/her parents or any other close relative.
5. The student will also deposit his/her photocopy of Computerized National Identity Card and of guarantor and all the witnesses.

6. Original academic documents deposited by student with NUST at the time of admission will be returned on clearance of dues amounting to Rs _____.
7. The student shall make himself/herself available for employment as faculty member, if his/her services are required by NUST.
8. Any increase in tuition fee or hostel charges will also be subjected to same concession of 50% deferment and 50% payment by the student. Finance Dte will accordingly reflect the same in tuition fee challans.
9. The provisions of deferment of tuition fee & hostel charges policy will not be applicable in following situations :-
 - a. Suspension of Registration.
 - b. Temporary suspension.
 - c. Tuition fee charges for summer courses.
